What data do we collect?

WorkStrong collects the following data:

- Personal identification information (Name, email address, phone number, etc.)
- Clinical details and information

How do we collect your data?

You directly provide WorkStrong with most of the data we collect. We collect data and process data when you:

- Register online or place an order for any of our products or services.
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email.
- Use or view our website via your browser's cookies.
- Consensual discussions with clinical staff and employees

WorkStrong may also receive your data indirectly from the following sources:

- Third-party organisations including insurers, solicitors and employers

How will we use your data?

WorkStrong collects your data so that we can:

- Process your order and manage your account.
- Email you with special offers on other products and services we think you might like.
- Undertake appropriate clinical and professional support and treatment

How do we store your data?

WorkStrong securely stores your data at 4th Floor, 113-16 Bute Street, Cardiff Bay, Cardiff CF10 5EQ and with Dropbox.

WorkStrong will keep your personal for 2 years (7 for clinical related information). Once this time period has expired, we will delete your data by system deletion and shredding of any information held on paper.

What are your data protection rights?

WorkStrong would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request WorkStrong for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that WorkStrong correct any information you believe is inaccurate. You also have the right to request WorkStrong to complete the information you believe is incomplete.

The right to erasure – You have the right to request that WorkStrong erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that WorkStrong restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to WorkStrong's processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that WorkStrong transfer the data that we have collected to another organization, or directly to you, under certain conditions.

How do we use cookies?

What types of cookies do we use?

There are a number of different types of cookies, however, our website uses:

- Functionality – WorkStrong uses these cookies so that we recognize you on our website and remember your previously selected preferences. These could include what language you prefer and location you are in. A mix of first-party and third-party cookies are used.
- Advertising – WorkStrong uses these cookies to collect information about your visit to our website, the content you viewed, the links you followed and information about your browser, device, and your IP address. WorkStrong sometimes shares some limited aspects of this data with third parties for advertising purposes. We may also share online data collected through cookies with our advertising partners. This means that when you visit another website, you may be shown advertising based on your browsing patterns on our website.
